SUBJECT: ALTERNATE APPROVAL PROCESS FOR BYLAWS 5507, 5508, AND 5509

RECOMMENDATION(S):

That Council approve January 6, 2020 as the amended deadline date for receipt of Alternative Approval Process elector response forms for Loan Authorization Bylaws 5507,5508, and 5509; and;

That Council approve, as a result of the proposed deadline amendment, updated Elector Response Forms, including the Public Notice, for the Alternative Approval Process for Bylaws 5507, 5508, and 5509 (Attachment A).

PURPOSE:

The purpose of this report is to request Council approval to amend the deadline for receipt of Alternative Approval Process elector response forms to January 6, 2020 and the approval of revised Elector Response Forms and Public Notice for the Alternative Approval Process for Bylaw 5507, 5508, and 5509 as presented in Attachment A.

ALTERNATE APPROVAL PROCESS FOR BYLAWS 5507, 5508, AND 5509 Page 2 . . .

DISCUSSION/ANALYSIS:

On September 9, 2019, Council approved the original Alternative Approval Process Elector Response Forms for the Alternative Approval Process for Bylaws 5507, 5508, and 5509 with a deadline date of November 29, 2019.

Staff originally submitted the borrowing bylaws and Liability Servicing Limit Certificate to the applicable Ministry for review and approval with the anticipated timeline of 6 weeks. Unfortunately, statutory approvals were not received until November 7, 2019.

The borrowing process as stipulated in the *Community Charter* and the Local Government Act for these bylaws, requires the Township seek elector approval through the Alternative Approval Process. Two public notices, in subsequent weeks are required, after which time Elector Response Forms will be available to the public at the Civic Facility or on the Township's website. The electorate will have 30 days after the second publication date to submit to the Corporate Officer, an original signed form registering their opposition.

To meet the timeline required under legislation, the deadline will need to be updated to **January 6, 2020** (from November 29, 2019). In addition, Elector Response Forms with the new deadline dates are required.
