#### 1. **Co-Chair Reports**

K. Reddington reported that a panel discussion regarding Seniors Housing and Homelessness took place on January 17. Panelists included: MLA, Rich Coleman, Major Jack Froese, Mayor Ted Schaffer, Brian Dodd, Executive Director, Seniors Services Society, and Roz Bailey, President, Surrey Home Owners Association. The Panel addressed such issues as seniors housing, affordable rent, and homelessness. 120 people attended and it was a very successful event. She further reported that the Healthier Communities Partnership made a delegation to the City and Township of Langley Council's in support of a Social Planner position in both municipalities.

Councillor Fox reported that public input for the 2017 budget is still available on the TOL website. He commented that the Panel discussion on senior's issues was a very informative event and that a seniors housing development will be built in the near future. He further noted that he has been appointed to the Metro Vancouver Homelessness Task Force and that they homeless count will take place on February 7 and 8.

In keeping with the spirit of Canada's 150 Anniversary being celebrated this year, the Heritage Advisory Committee cordially invites you to participate in the development of a project that will explore the history of Langley and the themes that have come to define who we are as a community today.

In 2012, Township of Langley Council endorsed a Heritage Strategy that outlines strategic goals and actions for heritage conservation to 2022 and beyond. Goal 7, pertaining to "Updating Heritage Policies in an Integrated Planning Framework", recommends development of an improved information base for the identification of Langley's heritage resources. One of its associated actions includes the development of a Historic Context Statement and Thematic Framework for Langley. The terms of reference for this project were prepared in consultation with the Heritage Advisory Committee as part of their 2016 Work Plan, and approved by Council in June 2016. The process to complete the context statement and thematic framework is being guided by a task force appointed by the Heritage Advisory Committee and endorsed by Council in September 2016, representing a range of stakeholders knowledgeable in the diverse aspects of Langley's past.

Beginning in August 2015 we began a journey to understand how to redesign care for seniors in Langley Community. We have learned much in that year and still more lies ahead – and we need your help. As we begin 2017 we wanted to create an opportunity to continue this community learning journey to better understand how each of us plays a role in creating a collaborative system of care. Starting February 23<sup>rd</sup> we begin out next phase with you all.

We are hosting a summit series with a broad group of community stakeholders intended to:

- 1. Bring transparency to the work around LINC for Langley in the past year.
- 2. Create a space to design solutions to shared community challenges around caring for seniors.
- 3. Commit to implementing and testing the solutions we discover together that enable "every door to be the right door" for a senior to access care in Langley.

As a refresher the Seniors' LINC is a Ministry of Health initiative that seeks to:

- 4. Connect seniors and caregivers to home and community-based services for education, health planning, and support.
- 5. Provide seniors with the services, supports and self-management skills they need to age in place.
- 6. Reduce unplanned emergency visits and admissions to acute care when care can be managed safely and effectively from the senior's home.

We hope you can join us at Langley Golf Club from 9 am - 3 pm on February 23<sup>rd</sup>. This will be the first in a series of 4 quarterly summits building over the course of 2017.
