## **D. REPORTS**

### **1. Co-Chairs' Reports**

T. Annandale reported that he has been attending the workshops for the Historic Context Statement and Themes Project, and commented that there has been great input from the attendees to date.

Councillor Long reported that Council approved the Heritage Advisory Committee motions on February 20 regarding the First World War Memorial trees in Fort Langley. The motions pertained to the replacement of the Big-leaf Maple tree stumps with new maple saplings; holding a tree dedication ceremony as part of the replanting; planting the Big-leaf Maple saplings as a grove in Hudson Bay Park; and giving the three salvaged branches from the Wilson Memorial Tree to Heritage Manor to construct a memorial bench for public use.

### **2. Heritage Planner's Report**

E. Horricks reported the following:

- Work will begin in the months ahead to restore the concrete base of the Murrayville Cenotaph. The 2016 Conservation Plan prepared for the cenotaph and supported by Veterans Affairs Canada who provided a substantial grant to complete the project will guide the work. The goal is to complete the restoration before November 11 this year.
- Following Council's passing of the committee's motion pertaining to the First World War Memorial Trees in Fort Langley, a tree dedication ceremony is being planned as part of the replanting of the three sites. The ceremony will take place on Arbour Day on Sunday, April 23 at 12:00pm at 96 Avenue and Glover Road. Arbour Day activities will commence at Hudson Bay Park following the tree dedication ceremony. Further details will be provided to the committee in April.
- Representatives of Heritage Manor have confirmed that they will follow up with F. Pepin of the Langley Heritage Society to arrange for the drying, milling and dispensing of the salvaged wood from the 96 Avenue and Glover Road site.
- She added that a committee orientation was provided to new members prior to the meeting.

### **3. Museum Manager's Report**

J. Chenatte reported the following:

- The Museum has received a number of grants and donations recently.
- The new display cases will be built soon, and repair work on the HVAC system has begun.
- An author has been commissioned to turn the Philip Jackman Legacy project into a book, and Jeff has written an article for the Federation of Friends of Museums quarterly magazine.
- The next exhibit "Sacrifice and Sorrow: Langley and the Great War of 1914-1918" will run from April 9 to July 16. A free curatorial talk with Warren Sommer will take place on April 11 at 7:00pm.

## D. REPORTS

- The Walnut Grove Banner Project for elementary school children has begun. The banner reception will take place on April 29 with the Mayor presenting certificates to all the finalists.
- The Museum is currently looking for exhibition ideas for 2018-2019.
- A Canada 150 Banner Project will be offered to school classes this year, sponsored by the Langley Heritage Society.
- The Museum offered 400 education programs in 2016, which exceeded the number in the previous year.
- Planning has begun for the Canada Day celebrations this year that will include an evening film festival at the Fort.
- Family Day was a success with just under 400 in attendance. The Murrayville bus tour and Fort Langley walking tour during Heritage Week were also well received.

### 4. Heritage Review Panel

T. Annandale reported that the Panel met to review revised drawings for the proposed Lily Terrace project in Fort Langley that has been redesigned to address engineering issues. The previous design was shared with the committee in November 2016.

He noted that the size of the site remains unchanged and there are still three building components to the project, including the Young Building, Sailes Block and Lily Terrace. In the new proposal, both the Young and Sailes buildings are proposed for commercial use with the Lily Terrace portion of the project remaining residential. Additional changes to the previous design include the removal of the below-grade commercial space and the split-level entries proposed for the three building components fronting Glover Road, Francis Avenue and Church Street. Parking is still accessed off Francis Avenue as originally proposed, and is the only element remaining below-grade in the revised proposal. A significant increase in parking is achieved in the revised plan of approximately 20% more than what is required.

The project provides for three floor levels of floor space with the top level built into the roof structure to meet the 9.0 meter height restriction. In the revised proposal, Sailes Block and Lily Terrace are more similar in form than previous, while all three components have moved toward a more residential appearance with the extensive use of gable and shed roofs throughout. The revised character of the project appears to blend well with the dominantly residential forms that characterize the south end of the conservation area. Materials for the different components and the corresponding colour palette still vary somewhat between the various components, as shown in the colour and materials board provided. The landscaped interpretive walkway along the north boundary of the site references the history of the historical names associated with the project through ground plaques etc. as originally proposed.

In summary, he noted that the Panel viewed the re-design favourably.

Discussion ensued during which it was recognized that a wide range of engaging activities ranging from geocaching to other forms of treasure hunts are likely to occur as a result of their being in place again. It was recommended that a news release from the Township be prepared on completion of the project as a starting point in raising public awareness of their reinstatement.

# PIONEER MARKER

## 2017



April 16, 2017.

Mayor Froese and Councillors of the Township of Langley:

Thank-you for allocating a portion of your time to consider this small, but important project I am bringing forward. Being a TOL resident and relative of several local pioneer families, I am proposing an expansion of the Pioneer Marker Program as we celebrate Canada's 150<sup>th</sup> Anniversary. We have an opportunity to reflect upon and recognize additional pioneers whose courage, tenacity, and struggles contributed to the "Birthplace of B.C." and the quality of life we enjoy today.

With the rapid growth of our community, we also are experiencing a parallel decline and loss of historical structures. I personally am advocating on behalf of the Holding and Larmon families, as well as providing the option for others to request Pioneer Markers be placed on as-of-yet unnamed roads.

I have researched family records and photographs, historical texts, and the TOL Centennial Museum in support of this proposal. I am requesting that 226<sup>th</sup> Street south of 64<sup>th</sup> Ave. (Medd Road) receive a marker "Larmon Road", and 224<sup>th</sup> Street north of Telegraph Trail receive a marker "Holding Road". Allow me to provide a condensed history of these two families.

**Holding Family:** Richard Henry Holding first arrived here in 1871 and purchased the homestead that today is the Belmont Golf Course. Holdings lived on the land until 2008, when the last parcel was sold to the golf course. Historical photographs denote the homestead as "Holdings Hill". Today the Holding girls still get together on a regular basis.

**Larmon Family:** Nathaniel Larmon arrived here in 1875 and pre-empted lands outside of the Hudson Bay Farm in Milner. Three generations farmed this land until the passing of "Johnnie" Larmon in 2000, where upon the land was purchased by investors. As a child I enjoyed visiting Alice and Johnnie, and seeing the dairy cows in the original barn. Magical times.

Medd Family: William Medd arrived late in 1875, and Larmon assisted him to purchase lands in Milner. Ann Holding (daughter of Richard Holding) married William Medd, and their daughter Alice married John Larmon. The Medd House is standing to this day, however is unoccupied.

These pioneers and their descendants were farmers, teachers, bankers, businessmen, lab techs, nurses, held public office, and were founding members of the Fraser Valley Milk Producers Association and the Fort Langley Community Improvement Society.

With the majority of our historic buildings already lost or in a state of decline, the cost to restore and maintain these structures is formidable and honestly, unrealistic. Pioneer Markers however, are a cost effective, easily produced and maintained, enduring, and publicly visible choice for honouring our local history. Modern technology can be implemented in replicating the existing Pioneer Marker signs, should the original templates no longer be available. I have met with our MLA, the Honourable Rich Coleman, and there is the likelihood of financial support through the provincial government. He has been an avid supporter of supporting Langley history. The TOL municipality may apply for funding through the Canada 150 Federal program. Individual applicants (such as myself) should also contribute a reasonable and appropriate amount towards the cost of their family's marker.

We are all proud to celebrate the major part that Fort Langley played in Canada's history, and I propose that a resolution be brought before council to vote upon, approve, and adopt the expansion of the Pioneer Marker Program 2017.

### Governor General's History Award for Excellence in Teaching

Canada's History established the award in 1996 with the following aims:

- to recognize excellence in the teaching of Canadian history regardless of the curricula in which it is taught
- to inspire teachers and schools to strive for excellence in Canadian history education
- to promote and facilitate the sharing of best practices and innovative teaching ideas within Canada's teaching community

#### The Prize

Six recipients will be awarded:

- An individual cash prize of \$2,500
- A \$1000 cash prize for their school
- A trip for two to Ottawa to attend the awards ceremony at Rideau Hall, the Canada's History Forum, and the History-Makers celebration dinner
- A medal awarded by the Governor General
- A trip with other educators on a battlefields tour, presented by EF Educational Tours.\*

*\*Itinerary and departure dates to be confirmed and subject to change. Team recipients will be awarded one trip and must select one individual to attend. Francophone recipients will have option to join a French-speaking tour. The cost of a supply teacher will not be covered by Canada's History or EF Tours.*

#### Eligibility

Whether you have been teaching in the classroom for three years or 30, the Society is seeking to celebrate leadership and innovation in teaching our young people about Canada's past. We welcome submissions from elementary, middle and senior school classroom teachers. Teachers can submit a project, a body of work, or a group or school-wide initiative.

To be considered, nominees must demonstrate that they have excelled in the teaching of Canadian history. Entrants must:

- be residents of Canada
- work directly with students in a school setting
- teach grades ranging from K–12 during the current school year
- teach units or full courses that include a significant component of Canadian history at any grade level

Self nominations are encouraged. Posthumous nominations will not be considered. Team teaching and school-wide initiatives are of particular interest to the Society, up to a maximum of three nominees. However, group recipients will be expected to share any financial rewards equally among the team. Past recipients may not reapply.

#### Criteria

Canadian history can be taught in many ways — as a self-standing course; through local or regional units; as a form of integrated social studies; or in courses devoted to literature, science, law, economics, geography, and so on. Teachers in all these areas are eligible for the award, provided that their work features Canadian content and has an explicitly historical dimension.

A committee of judges will select six recipients based on a submission outlining the nominees' achievements and innovations in the field of teaching Canadian History or Social Studies. Nominees must meet the following criteria.

Teachers must:

- Demonstrate a commitment to Canadian history in their teaching.
- Demonstrate that their teaching has an impact and that:
  - students gain a better knowledge and understanding of Canada as a whole, so that even a local or a regional study teaches them something about the nature and history of Canadian society in general
  - students understand how Canada's past connects with its present and future
  - students gain a continuing interest in Canadian history
  - students are required to learn and apply both knowledge and skills in their study
  - students gain an awareness of the nature of history as an intellectual discipline
  - history content is comprehensive and incorporates factual knowledge with broader themes, concepts and ideas and the study of specific events, ideas, movements and peoples
  - students learn to assess historical evidence, to understand the balance between fact and interpretation, to consider questions of bias, accuracy, objectivity
  - students experience a variety of teaching and assessment strategies, resources and materials
  - students are actively involved in the learning of history

**Note:** It is recognized that these criteria will not apply with equal force to all grades and kinds of students, or to all kinds of classroom settings. Therefore, the criteria will be applied with appropriate consideration for the type, age and level of students involved.

Application

Teachers are asked to submit a unique project that is representative of their approach to teaching history. The application form consists of five, short answer questions. Teachers are also asked to submit a lesson plan, rubric, student work exemplars, and two letters of reference. Projects must be submitted through the online application process. **The submissions deadline is April 24.**

## Governor General's History Award for Excellence in Community Programming

Canada's History aims to inspire small, volunteer-led community organizations in the creation of innovative programming that commemorates important aspects of our heritage.

The Prize

Two recipients (French and English) will receive \$2,500 each, and a trip for two to Ottawa to receive their award at the Governor General's History Awards at Rideau Hall in the fall. Recipients also attend the Canada's History Forum and the History-Makers Celebration Dinner, held in conjunction with the awards.

Eligibility

- All projects must be presented in Canada, by Canadians
- Individuals, project teams, and organizations are all eligible to receive the award
- Communities are defined as both cultural and geographic
- Nominations must be supported by at least one recognized historical, municipal, or educational organization
- Eligible types of projects include: civic engagement activities, exhibits, multimedia, preservation projects, and public programming
- Projects must have occurred within the past 18 months prior to the close of nominations

Criteria

- Projects will be evaluated on their audience reach, community impact, and contribution to greater public understanding of Canada's History. Special consideration is given to new and promising ideas, approaches, and innovations that will serve as a model for the field.
- Projects should involve a large number of participants from the community in both the creation and execution of the project. Communities can include both geographic that cover small and large areas, as well as cultural communities that represent a broad range of history and traditions.
- Specifically, judges will be looking for projects that are highly inspirational, exhibit exceptional scholarship, and/or is exceedingly entrepreneurial in terms of funding, partnerships, or collaborations, creative problem solving, or that unusual project design and inclusiveness.

Application

Applicants will need to complete a form consisting of five questions as well as submit relevant images, documents, links, and two letters of reference. Applications must be submitted online; physical applications are no longer being accepted. **The submissions deadline is June 30th.**

### The Fund will provide two types of support:

1. Project bursaries up to \$2,500 for candidates who propose special projects, results-oriented travel and participation at conferences and events that continue Herb's passion for community innovation and/or international dialogue in built heritage conservation theory and practice. 2. The National Trust for Canada Conference bursaries cover the cost of travel, conference accommodation and registration (approximate value \$1,000) for candidates to attend the National Trust's annual conference (Ottawa, ON, Oct 11-14, 2017).

### **ABOUT HERB STOVEL**

All who knew Herb Stovel understood his commitment to heritage conservation and, more importantly, his strong support for education and preparing a new generation of professionals. Over a period of decades, he generously passed on his insight and knowledge, which have helped define the theory and practice of heritage conservation for the 21st century in Canada and internationally.

In Canada, he taught as professor at Université de Montréal and at Carleton University. Early in his career, he developed courses for the National Trust's Main Street® program, which prepared over 100 professionals in communities across the country for careers in downtown revitalization. His training of federal employees reached across disciplines and departments, most notably perhaps with the Federal Heritage Building Review Office (FHBRO) course. Herb believed in empowering others and giving them the means to spread the word as broadly as possible. He developed train-the-trainer courses to put this knowledge into the hands of those best placed to deliver it. Then he moved on.

It is no exaggeration that Herb Stovel had students and followers in every corner of the globe. He believed in people and brought them together in the name of heritage conservation, leaving behind conflicts of war and politics, and allowing them to work together towards a common goal.

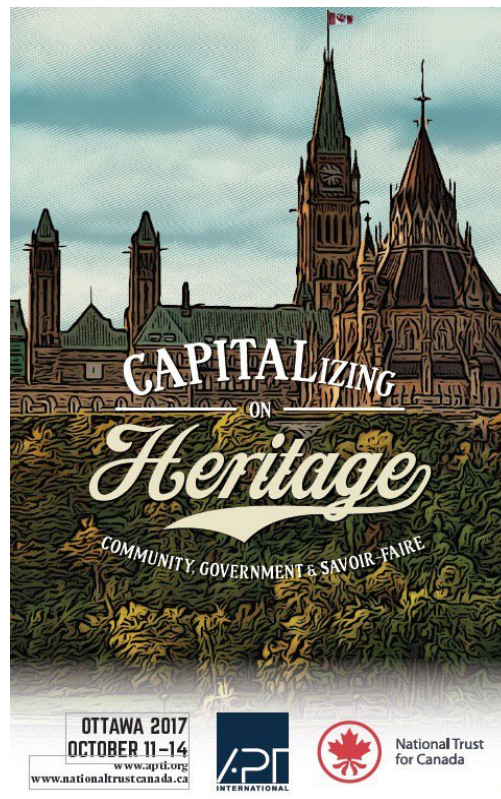
