### **D. PRESENTATIONS**

#### **D.1 MedWatch/Greensleeve Program**

Jason Hodge, Township of Langley Fire Department, and Barb Stack, Langley Division of Family Practice, provided a presentation regarding the MedWatch/Greensleeve program. They noted this program was developed out of a need to get vital health information and medical wishes to emergency responders and physicians. The Greensleeve packet keeps all important information in one place, including: contacts information, medical conditions, medications, and advance care plan. Within 48 hours of being hospitalized, almost half of adults age 65 or older need someone else to help make medical decisions, and having this information available is crucial to health care providers.

#### **D.2 Truck Route Review**

Richard Welfing, Township of Langley, and Gary Vlieg, Creative Transportation Solutions Ltd., provided a presentation regarding amendments to the municipal truck route network in north Langley. The purpose of truck routes is to provide trucks with specific corridors on which to travel so as to benefit the community while minimizing the impacts. The background and history regarding truck routes in the Township were provided, as well as existing conditions. The proposed additional truck routes for Fort Langley and Walnut Grove were presented, as well as removals from the truck route (see item F.1 for details). Next steps, subject to Council approval, include initiating application with TransLink, conducting a public information session, and bring forward amendments for Council's consideration.
