The Council is hereby authorized and empowered to borrow an amount or amounts not exceeding the sum of seven million dollars (\$7,000,000), as the same may be required.

The form of obligation to be given as acknowledgement of the liability shall be a promissory note or notes bearing the corporate seal and signed by the Mayor and the Financial Administration Officer.

The money so borrowed shall be used solely for the purposes set out in said Facility Capital Works Loan Authorization Bylaw 2018 No. 5346.

The proceeds from the sale of the debentures or so much thereof as may be necessary shall be used to repay the money so borrowed.

The money so borrowed shall be used solely for the purposes set out in said Transportation Capital Works Loan Authorization Bylaw 2018 No. 5347.

The proceeds from the sale of the debentures or so much thereof as may be necessary shall be used to repay the money so borrowed.
