RECOMMENDATION(S):

That Council give first, second and third reading to Council Advisory Committee Establishment Bylaw No. 4700, Amendment Bylaw 2019 No. 5473.

EXECUTIVE SUMMARY:

At the Regular Afternoon Council meeting of April 1, 2019, Council directed staff to amend the Council Advisory Committee Establishment Bylaw to include a representative from the Fraser Health Authority as a non-voting member on the Seniors Advisory Committee. Staff have prepared an amending bylaw for Council consideration as directed.

PURPOSE:

At the March 20, 2019 Seniors Advisory Committee (SAC) meeting, the SAC adopted a motion to request Council direct staff to amend the Council Advisory Committee Establishment Bylaw to add a representative to the SAC from the Fraser Health Authority as a non-voting member. In response to this request at the April 1, 2019 Regular Afternoon Council meeting, Council adopted the following resolution:

That Council direct staff to prepare an amendment to Council Advisory Committee Establishment Bylaw No. 4700 to include a Fraser Health representative as a non-voting member on the Seniors Advisory Committee.

Council Advisory Committee Establishment Bylaw No. 4700, Amendment Bylaw 2019 No. 5473 has been prepared by staff for Council's consideration as directed.
