South ½ Lot 26 Section 23 Township 7 New Westminster District Plan 2515; and

North ½ Lot 26 Section 23 Township 7 New Westminster District Plan 2515;

as shown delineated on Schedule "A" attached to and forming part of this Bylaw to Residential Zone R-1D.


