#### D. PRESENTATIONS

#### D.1 Langley RCMP

Supt. Murray Power, Langley RCMP Detachment, provided an update on police matters within the Township of Langley. He noted that the police service is not just about catching criminals. It is also about mental health, drug trends, and social challenges, including homelessness. He reported that there is no significant increase in property offences and person's offences during 2019.

Sgt. Matthew LaBelle reported that there are three Langley Traffic teams; two enforcement teams and one Criminal Collision Investigation Team. The Langley Traffic teams reduce serious-injury and fatal collisions, detect and apprehend impaired drivers, and target and apprehend prolific and prohibited drivers. It was further noted that Langley officers serve a greater number of citizens than officers in other detachments.

#### E. DELEGATIONS

#### E.1 Dan G. Mooney File 0550-07

Dan G. Mooney appeared before Council to discuss the benefits of opening 24 Avenue at 196 Street. He commented that the opening the road will not increase traffic, but rather re-distribute the traffic through the area. He further stated that adding a connection road results in a reduction in traffic on each individual road. He asked Council to open 24 Avenue sooner rather than later.

### E.2 Fort Langley Business Improvement Association File 0550-07

Lisa Smit, President of the Fort Langley Business Improvement Association, appeared before Council to discuss the renewal of the Fort Langley BIA bylaw. She asked Council to reject the staff recommendations from the December 2 report, to approve a three year renewal by a "petition Against" process, and to authorize staff to engage with the FLBIA to develop reasonable timelines and conditions for future renewals.
