This trail has become a nuisance and a hazard. It interferes with the rights of the owners/tenants of the property, to use or enjoy their property in a safe, stress free environment.

All transients, drug dealers and druggies are using the trail entering from 200th street.

They using the trail, under the pine trees and the creek to do:

\*drug deals - with stolen merchandise or money exchanged

\*shooting up - heating up heroin in tinfoil and extracting it into needles and proceeding to shoot up in the middle of the trail

\*finding males face down in the dirt passed out and dying from an overdose, and having to call the police.

\*defecating and urinating on the trail, in the bushes and on our yard fences in daylight hours.

\*traveling in packs of 3 to 6 males.

\*traveling with weapons.

\*leaving dirty condoms, countless used needles with left over heroin inside, used undergarments, lighters, tinfoil from heroin, burned paper, butcher knives, drugs and other drug paraphernalia, full pill bottles, garbage, shopping carts, security tags on the trail.

\*screaming, fighting and disturbing the people who live on the property.

\*beatings by our back door with bats, leaving blood on the trail.

\*damaging habitat to make trails down to the creek to bathe.

\*druggies looking into our back yards to steal items.

This list is not complete, at this point we the owners fear being attacked, our children harmed, our homes being broken into. The owners and myself have numerous pictures and videos of aggressive males who are verbally attacking the owners, doing drug deals, shooting up and many more pictures of items from the list above.

Our strata president, whos back yard is also on the trail off 200th street is in agreement that when the trail is closed and fenced off, we will remove that section of the path entering from 200th street, which is on strata property, and push back our back yard fences which to prevent any more issues.
