## C.1 Blaauw Eco Forest Agreement

David R. Clements, Trinity Western University, provided a presentation regarding the success of the Blaauw Eco Forest Agreement. He noted that the 25-acre parcel of land was bought from the Township by Trinity Western University using donated money from the Blaauw family. The land is now preserved for environmental research, education, and recreation purposes. The oldest tree sampled in the forest was 111 years old. A species inventory was compiled in the summer of 2016.

# D.1 Carolyn Schoenit File 0550-07

Carolyn Schoenit, on behalf of her mother, appeared before Council to discuss Water Local Area Service – 64 Avenue and 224 Street. She commented that her mother owns two farm properties on 64 Avenue and has been accessed a cost of \$123,000 for the waterline. This does not include the cost to hook up to the water. She stated this would be an undue hardship for her mother and for other farmers in the area who are not interested in having the waterline. She asked Council to re-consider this Water Local Area Service.
