### A. ADOPTION AND RECEIPT OF AGENDA ITEMS

# 1. Council Priorities Committee Meeting – January 30, 2017

Moved by Councillor Arnason, Seconded by Councillor Quaale, That the Council Priorities Committee approve the agenda and receive the agenda items of the January 30, 2017 meeting. CARRIED

### **B. PRESENTATIONS**

### 1. Township of Langley Cemeteries

Tab Buckner provided a presentation regarding the future of Township of Langley cemeteries. He noted that there are three cemeteries in the Township: Fort Langley, Murrayville, and Langley Lawn. The following changes have been made to the recently revised Cemetery Bylaw, adopted by Council on December 12, 2016:

- Re-introduction of upright headstones;
- Use of scattering gardens;
- Single cremations lots to be used as double lots;
- Permit up to eight urns versus four on a casket burial lot;
- Creation of Surplus Fund.

The following definitions are contained in the Bylaw:

- Resident any person residing in the Township of Langley and for a continual period not less than one year.
- Non-resident does not live in the Township of Langley

## **B.** PRESENTATIONS

- Former resident any person who resided in the Township of Langley for a continuous period of three years within the ten years before the date of application for a right on interment.
- Family member parent or step parent, grandparent or stepgrandparent, sibling (natural, adopted, or step) spouse, a child (natural, adopted, or step), or a grandchild (natural, adopted, or step).

The differences between a resident and non-resident are as follows:

#### Resident:

- Interment fees are half the fees of a non-resident
- At-need Right on Internment (ROI) for in-ground burial of human remains (also includes former resident and family members)
- Pre-need right of interment may only be issued to a person who is 65 years or older, has been a resident for a least 20 consecutive years at the time of application, is a former resident who has a family member interred in the cemetery where they are applying to be interred.

#### Non-resident:

- Interment fees are twice the cost of resident feeds
- No pre-need right of interment
- At-need ROI only for cremated human remains only in a cremation plot, cremation boulder, a niche wall, or a scattering garden.
- No ROI for in-ground burials of human remains
- If a spouse has already been interned at one of the TOL cemeteries, the remaining non-resident spouse would be considered a family member and would be allowed to be interned.

- 2. Increasing the number of municipalities used to survey for burial costs.
- 3. Restricting Murrayville and Fort Langley cemeteries to "pioneer residents" (lived in the Township of over 25 years).
- 4. Allowing staff to have access to Township of Langley cemeteries at resident rates.
- 5. A pet cemetery in the Township of Langley.
