## A. ADOPTION AND RECEIPT OF AGENDA ITEMS

## B. ITEMS FOR DISCUSSION

#### 2. Fire Department Update

Fire Chief Gamble provided a community safety update as per Policy No. 01-034. He presented the following information:

- The Township of Langley had a total of 6,568 calls for service in 2016. That is an increase of 9%.
- Fire calls are decreasing which is a good sign.
- Monty Armstrong was hired as the Assistant Chief of Administration.
- His key skills include fire prevention and suppression, project management, and occupational health and safety.
- The Fire Department Recognition Event was a successful event with over 275 attendees at George Preston Recreation Centre.
- The 2016/2017 Boot Drive raised over \$50,000 for Muscular Dystrophy.

#### B. ITEMS FOR DISCUSSION

- Sent crew members to Colorado for Crude by Rail Training and Tank Care Specialist Training. No cost to the community and very beneficial for the department.
- The Fire Department has administered Narcan Nasal Spray in 20 opioid overdose incidents.
- The Township will become a Class A shareholder with E-Comm and join the radio system.
- The Langley Emergency Program deployed 12 volunteers to help with Emergency Social Services with the BC wildfires.
- Firefighters were also deployed to help fight the fires throughout the summer.
- An Emergency Preparedness Fair will take place on October 14, 2017 at Kwantlen University Parking Lot.

#### 1. Property Tax Rates

K. Sinclair provided a presentation on Property Tax Rates. She provided the following information on how property tax rates are determined:

Property Tax Rates - Year 1

- Property tax revenue required
  - Annual Operating Expenditures, minus annual non-tax revenue equals property tax revenue required.
- Assessed values are needed (provided by BC Assessment)
- Property tax rates
  - Property tax revenue required, divided by total assessed value, equals property tax mill rate.

Property Tax Rates – Year 2 (When assessed values have changed)

- Step 1
  - Calculate the tax rate needed to generate the same property tax revenue as the previous year but on a new higher property value.
- Step 2
  - Apply the Council approved increase.

Residential properties are divided into sub-categories:

- Residential Vacant
- Single Family Dwelling
- Residential ALR
- Farm
- Strata
- All other

Property tax rates are adjusted using a 35% Class 1 average.
