D. PRESENTATIONS

D.1 Fraser Valley Regional Library

Heather Scoular, Director of Customer Experience, and Nancy Gomerich, Director of Finance, Fraser Valley Regional Library, provided Council with information on the 2018 Strategic Plan and the 2018 budget planning. They presented the revenues and expenses projected for 2018 and stated that it is important for the public library to develop programs and lending opportunities to educate its customers. The five strategic plan themes are: inspiration, a welcoming place, partnerships, engaging staff, and know us-love us. To achieve the five themes, annual plans will be developed each year with corresponding initiatives.

D.2 Social Sustainability Strategy Terms of Reference

Patrick Ward, Strategic/Social Planner, provided a presentation on the Terms of Reference for the preparation of a Social Sustainability Strategy. He noted that social sustainability focuses on issues that contribute to wellbeing and quality of life, and involves meeting basic needs and providing opportunities to enhance human and community capacity. The proposed Social Sustainability Strategy will build upon and help implement the Sustainability Charter, and is referenced in the Township's Official Community Plan adopted in 2016. The Terms of Reference outline eight principles and assumptions to guide the preparation of the Strategy, and are intended to shape the development of the Strategy's goals, actions, and implementation. The preparation of the Strategy will consist of five phases of work and is expected to be completed in early 2020.
