E. DELEGATIONS

E.1 Margaret Kent File 0550-07

Margaret Kent appeared before Council to discuss potential excessive noise issues with the construction at Willowbrook Mall. She expressed concern on the possible future noise pollution levels. She requested that there be no nighttime construction and also that noise barriers be installed to mitigate noise and dust pollution.

E.2 Anya Paskovic Aplin & Martin Consultants File 0550-07

E.3 John Moonen File 0550-07

Bob Bortolin and John Moonen, Axon Lumber, appeared before Council to discuss Agricultural Land Commission Application No. 100307 (Axon Lumber Ltd. / 25895 – 88 Avenue). They would like to use the northern 1/3 of the site (approximately 14 acres) for industrial purposes, have it subdivided from the main property, excluded from the Agricultural Land Reserve, and rezoned to M-5 (industrial). The remaining 2/3 of the property will remain in the ALR and be more intensively farmed. The northern portion of the property regularly floods and would require \$2 million to rehabilitate for agriculture. They would like to use this portion

of land for a building to store raw materials, lumber, and supplies, and also have an office with washrooms, a lunchroom, and related amenities.
