D. PRESENTATIONS

D.1 Reducing Particulate Matter Emissions from Open Burning in Rural Areas

Kathy Preston, Air Quality Regulatory Lead, Metro Vancouver, provided a presentation regarding reducing Particulate Matter Emissions due to open burning on agricultural land. She commented that Metro Vancouver is working towards avoiding burn emissions and helping farmers improve their burning practices. She noted that open burning on agricultural land can cause short-term spikes of ambient particulate matter that can affect residential areas and create health concerns. Emissions can be reduced by: recycling and re-using, composting, and using best burning technologies and practices. Metro Vancouver's Air Quality Management Bylaw prohibits open burning by a business unless authorized by an Open Burning Approval. Typical requirements for Open Burning Approval include: use of a brush-fire fan or air curtain burner, maximum hours per day for burning, stop adding fuel two hours before sunset, list of prohibited materials, and someone must be on site at all times.

He would like to have a business license for Green Canada World Sign Ltd. which provide anti-glare digital led billboards. He stated that this will create jobs in the Township, generate revenue, and help the environment.
