1. Council Co-Chairperson's Report

Councillor Richter reported on Council's budget meetings and informed the committee that there will be two Budget Open House opportunities late February.

E. CORRESPONDENCE

John and Muriel Arnason Volunteer Award Criteria from Councillor Arnason

E. Erickson reviewed the email received from Councillor Petrina Arnason regarding her response to the suggested changes to the John and Muriel Arnason Volunteer Award Criteria put forward by the Task Force. She commented that she does not want to see the criteria altered to reference nominees who have made a "significant contribution" to the Township of Langley, but instead leave in the criteria that states a "partnership of those advocating for culture, learning, and literacy". She feels changing this criteria would effectively minimize or completely remove the very select interests which were the genesis of the award.

She further commented that she would not like the Township of Langley residency requirement to change as it will undermine the current connection to on-going activities in the Township.
