# **B. PRESENTATIONS**

# B.1 Non-medical Cannabis Retail Sales Development Applications

R. Seifi provided a presentation on non-medical cannabis retail sales development application processing, as per Council's direction. He noted that on April 20, 2020, Council adopted a number of procedural bylaw amendments to accommodate non-medical cannabis retail sales in the Township. On September 21, 2020, Council received a report from staff grouping all applications received by August 31, 2020 together, organized by community complete with additional selection criteria, and referred the applications to a special meeting to be held October 19, 2020, to review each application in detail. The process for applicants showing municipal versus provincial responsibilities was presented. Policy #07-410 "Cannabis Retail Sale", adopted by Council on March 3, 2020, provides scope, purpose, locational criteria, and process for staff and Council to follow.

Applications received as of August 31, 2020 are as follows:

- Aldergrove 8
- Carvolth-200 Street interchange 3
- Fort Langley 3
- Murrayville 1
- Walnut Grove 1
- Willoughby 1
- Willowbrook 3

The application status for each applicant was presented.
