1. Langley Seniors in Action

P. Crump, Chair, Langley Seniors in Action, presented an overview of the organization. He noted that this group was formerly the Langley Seniors Community Action Table and that they became a registered society in 2020 and re-branded themselves to be Langley Seniors in Action. The focus of the organization is to:

- Facilitate seniors' leadership and involvement in the community;
- · Recognize local issues and opportunities;
- Share information and resources: and
- Build partnerships with other community services.

Some of the issues they have addressed include:

- Housing
- Transportation
- Education and awareness (e.g. online workshops)
- Health
- Social isolation
- Elder abuse

- Equity, inclusion, and seniors
- Opportunities for additional seniors' centres (e.g. Willoughby)
- Connecting seniors with children and youth
- Engagement with First Nations and Indigenous organizations
- Seniors and community connectedness
